National Recognition

Course Aims & Objectives

Entry Requirements & Prerequisites

All prospective students must be physically able to perform the practical activities for the baton and handcuffs training.

You will be required to complete an "Application for Enrolment and an LLN" form which can be obtained from the reception or website. You will be placed depending on the vacancy.

Work Placement

The Baton and Handcuffs training provides applicants the skills and knowledge necessary to seek employment in a higher level operational security position for example, Night Patrolling, Major Events, Gatehouse Guard etc...

Completion Requirements

To achieve a statement of result applicants must have demonstrated competency against all 2 elective units. The units of competence and nominal hours for completion are as follows:

CPPSEC3014A Control persons using baton
CPPSEC3015A Restrain persons using handcuffs

Assessment

Students will be required to be assessed in this program, to show that they have achieved the skills and knowledge set out in the competency standards/modules.

Assessment may include a variety of approaches e.g. demonstration, written work, case studies, log books, and reports.

Resources & Facilities

Prospective Security students will be provided to use all required textbooks and equipments. Classes will be conducted as required in an appropriate learning environment.

Course Fees & Charges

The course will start from \$350.00. A minimum payment of \$150.00 is required prior to course commencement for administration and enrolment fee. All cancellation requests made prior to course commencement date will incur a \$150.00 administration and enrolment fee.
